FOLIAR APPLICATIONS:

Apply Earth-Hume at the rate of 1/4 - 1 gallon per acre, per application, in enough water to provide for thorough coverage. Earth-Hume can be used in most crop protection sprays.

SOIL APPLICATIONS:

Apply Earth-Hume at the rate of 1/4 - 1 gallon per acre, per application, with most soil applied liquid fertilizers.

COMPATIBILITY:

Compatible with most pesticides and fertilizers. Mix Earth-Hume with neutral liquids (pH 7.0). DO NOT MIX WITH ACID SOLUTIONS.
